### Education and Encouragement

## Crossing Guards

- Crossing guard sites are periodically re-evaluated, scored, and ranked based on a number of factors including vehicle volumes, speeds, and school-aged student volumes
- o Some Novato locations have ranked in the top 10 countywide for this evaluation period.
- Some new locations have guards in Novato this year: Trumbull & Vineyard, Woodland & Siebel, Sutro & Center, Center & Diablo
- Some locations that currently have a crossing guard did not rank high enough to retain the guard: Center & Tamalpais, South Novato & Sunset. These locations may have had safety improvements making them no longer need a crossing guard. South Novato and Sunset will retain its guard, which would be funded by the school district.
- o Information is being communicated through task forces, superintendents, PTA, and on-site notifications regarding new site and discontinued site

## Novato High Walk Audit

- Walk audit focused on Arthur Street and the parking lot.
- Congestion and conflicts around the parking lot entrance with backups to South Novato Blvd. cars enter from the east and exit to the west. Students are dropped off on the driver side of vehicles, which is abnormal for operations. One idea would be to reverse the vehicle flow to correct this with cars entering in the west and exiting in the east. Offsite, this would reduce congestion along Arthur Street due to reduced conflict between right-turning exiting vehicles and entering vehicles.
- Within the parking lot, some aisle vehicle directions could be shifted to reduce congestion and facilitate more normal drop-off operations. A dedicated walkway would be added for students walking to campus. Adding wheel stops to parking spaces would prevent vehicles cutting through.
- Arthur and Hayes intersection: idea to add more red curbs to increase sight lines, add curb
  extensions, and add signage warning drivers about the crosswalk. Also, opportunity to
  widen sidewalk
- Arthur and Cambridge intersection: could add curb extensions to provide shorter crosswalks and better visibility
- South Novato and Arthur intersection: Potential opportunity to add stop bars, high visibility crosswalks, and buffered bike lanes
- o Hundreds of parents drop students off in the parking lot as well as off-site
- Student parking spaces are assigned, so students entering the middle row in the parking lot would do so only to park.
- Education will be very important if the parking lot is reconfigured.
- Rectangular rapid flashing beacons could be considered at the intersections

- Would be helpful to communicate to parents where they can drop students off campus. A
  drop-off spot at the back of the school was assessed during the walk audit but it's not ADA
  compliant.
- Next steps: the city is interested in pursuing the ideas. Parisi will meet with the school and the city to discuss further.
