• Education and Encouragement

- o National Bike to School Day yesterday postponed until next Wednesday due to the rain
- Last activity of the year: Bike Hero Award. Two countywide elementary and two middle school student winners will be named at the end of the month
- Classes coming up at Del Mar week of May 16: this will wrap up the district's education for the year

Crossing Guards

- Sites are re-evaluated periodically to ensure that crossing guards are present where there is the most need. The latest evaluation was postponed to 2023 due to the pandemic.
- The current list of crossing guards includes 103 crossing guards
- Criteria for crossing guard location evaluation include vehicular volumes, school-aged pedestrian volumes, stopping sight distance at intersections, etc. crosswalks are scored individually, and the site score is the highest crosswalk score.
- Changes to sites have resulted from declining school enrollment, completed capital projects, signal timing, no right on red, and school closure/consolidation
- o Changes for Reed, to be implemented in the fall

- New location: Avenida Miraflores & Hilary
- Discontinued sites: Blackfield & Cecilia, Blackfield & Tiburon
- Notice of the upcoming changes, once finalized, will be distributed through task forces,
 PTAs, on-site, etc. prior to the changes being implemented
- PTAs/school districts can self-fund a crossing guard through the TAM program. A volunteer program also exists, but the district would be required to furnish a guard for the entire year or be charged up to the full cost of a crossing guard. The town could also choose to fund a guard.
- Concern was expressed on losing the Blackfield crossing guards. The location at Tiburon Blvd was discontinued already due to changes in the condition that improved safety. With the new bike access, kids are riding on the street and using the crossing guard less. The Cecilia site could be funded through the city or the school district.

Street Smarts

- o The spring Street Smarts Eyes Up campaign is ongoing through the end of May

Caltrans updates

- o Unfortunately, Caltrans representatives failed to attend the meeting as had been promised.
- David Eshoo reported. Proposed bike lanes along Tiburon from North Knoll to Blackie's
 Pasture: Stephanie Moulton-Peters and other legislators have written a letter to Caltrans
 supporting Class IV bikeways on both sides of the street, which had previously been planned
 for class II. The detailed designs are still upcoming.
- Still no word yet about the intersections improvements that have been requested.
- Caltrans is focusing on the Environmental review and said there was still time when they go
 into design. However, there is concern that without environmental review, the
 intersections will not be included
- Safe Routes will work with the city and Supervisor Moulton Peters office to work with Caltrans. TAM funding might be needed for the intersections.

Cove Parking lot

- David Eshoo is in contact with the shopping center management company. Recommending
 a painted pathway from Cecilia along the building through the parking lot, connecting with
 an existing crosswalk in the lot. The shopping center is open to this idea.
- Recommending trimming bushes at the shopping center entrance to reduce sight obstructions
- It would be the responsibility of the property owner to put in the pathway, which would involve paint and ADA slopes (possible minor improvements).

Town Updates

- Stall with the RRFB/HAWK system at Stewart owing to electrical issues
- A secondary RRFB was placed about 2' above the property owner's fence line. Working on redesigning the pole so the light doesn't disturb the property owner. Trying to get this finalized before the fall semester starts

Greenwood Cove Flooding

- Blackfield to Greenwood Cove is in the County, transitions to Tiburon at Greenwood Beach.
 This road floods and obstructs access. Flood Control is aware of this issue; the County is working with CalTrans.
